More than two hundred people were accused. Thirty were found guilty, nineteen of whom were executed by hanging (fourteen women and five men). The Witchcraft Trial In 1674, Bridgman charged Parsons with witchcraft. After her slander lawsuit, the rumors in Northampton about Parsons being a witch had subsided. However, the sudden death of Sarah Bridgman's daughter, Mary Bartlett in July 1674 prompted her mother to formally accuse Parsons of witchcraft.
